## POLICY ON DETERMINATION OF MATERIALITY FOR DISCLOSURES

### **I. BACKGROUND**

Regulation 30 of Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 [hereinafter referred to as “SEBI (LODR) Regulations”] mandates that every listed entity shall make disclosures of any events or information which, in the opinion of the Board of Directors of the listed company, is material as well as any price sensitive information. The listed entity shall frame a policy for determination of materiality, based on the specified criteria duly approved by its Board of Directors, which shall be disclosed on its website.

The Board of Directors of the listed entity shall authorize one or more Key Managerial Personnel for the purpose of determining materiality of an event or information for the purpose of making disclosures. In view of the same, this “**Policy on Determination of Materiality for Disclosure**” of **NATIONAL STEEL AND AGRO INDUSTRIES LIMITED** (“the Company”) has been framed considering that stakeholders of the Company need timely, sufficient & reliable information and communication in a coherent manner regarding material events that matters / makes influence on the Company as also the regulatory requirements of Regulation 30 of the SEBI (LODR) Regulations.

### **II. DEFINITIONS**

#### **a) AUTHORIZED KEY MANAGERIAL PERSONNEL**

Authorised Key Managerial Personnel means Executive Chairman / Managing Director, who is authorized, for determining the materiality of an event or information that qualifies for disclosure and to decide the appropriate time and details of its disclosure to be made to the Stock Exchange(s).

**b) BOARD OF DIRECTORS**

Board of Directors shall mean Board of Directors of National Steel and Agro Industries Limited.

**c) POLICY OR THIS POLICY**

Policy or this policy means **“Policy on Determination of Materiality for Disclosures”**.

**d) STOCK EXCHANGES**

Stock Exchanges mean BSE Limited and National Stock Exchange of India Limited where the Equity Shares of the Company are listed.

**III. INTERPRETATION**

Terms that have not been defined in this policy shall have the same meaning assigned to them in the SEBI (LODR) Regulations, SEBI Act 1992, Securities Contract (Regulation) Act 1956, Depositories Act 1996, Companies Act 2013 and/or the Rules & Regulations made thereunder as amended from time to time.

#### **IV. POLICY**

The Company will as soon as reasonably possible inform the Stock Exchange(s) of all the events or information which will have material impact on the performance/operations of the Company, as well as any price sensitive information. The "Authorised Key Managerial Personnel" shall be entitled to take a view on the materiality of an event or information which are qualifying for disclosure as provided in Para B of Part A of Schedule III of the SEBI (LODR) Regulations and to decide the appropriate time at which such disclosure is to be made with the Stock Exchange(s) and details that may be disclosed in the best interest of present and potential investors.

#### **V. REPORTING AND DISCLOSURE**

Regulations 30 of SEBI [LODR] Regulations, 2015, have categorized material events and information which will have bearing on the performance/operations of the Company. The disclosures of events and information which the Company shall make to the Stock Exchange(s) as broadly categorized under these regulations are as under-

- i. Events in category A shall be disclosed to Stock Exchanges without any application of the guidelines for materiality i.e. these are mandatorily to be disclosed irrespective of the extent of happening of event. (Refer Annexure - 1)
- ii. Events that have been provided in category B shall be disclosed to Stock Exchanges upon application of the guidelines for materiality to

be determined by the Authorised Key Managerial Personnel on the basis of criteria as mentioned in Regulation 30(4). (Refer Annexure - 2)

- iii. Any other material event or information as per Category C, which have not been covered under Category A & Category B, shall also be disclosed to the Stock Exchanges upon application of guidelines for materiality to be determined by the Authorised Key Managerial Personnel on the basis of criteria as mentioned in Regulation 30(4). (Refer Annexure - 3)

## **VI. CRITERIA FOR DETERMINING MATERIALITY OF EVENTS / INFORMATION**

- (a) The omission of an event or information, which is likely to:
  - result in discontinuity or alteration of event or information already available publicly; or
  - result in significant market reaction if the said omission came to light at a later date;
- (b) In the opinion of the Board of Directors of the Company, the event or information is considered material and ought to be disclosed.

## **VII. IMPLEMENTATION**

The Company will adhere to highest standards with regard to the implementation of this policy. The Executive Chairman / Managing Director of the Company shall have overall responsibility for implementing

of this policy and shall take internal/external approvals, wherever necessary.

#### **VIII. POLICY REVIEW**

This policy shall be reviewed from time to time so that the policy remains competent with applicable legal requirements. The Company Secretary will keep the policy updated as per applicable statutory guidelines.

## ANNEXURES - 1

### **EVENTS WHICH SHALL BE DISCLOSED WITHOUT ANY APPLICATION OF THE GUIDELINES FOR MATERIALITY AS SPECIFIED IN SUB-REGULATION (4) OF REGULATION (30)**

1. Acquisition(s) (including agreement to acquire), Scheme of Arrangement (amalgamation/ merger/ demerger/restructuring), or sale or disposal of any unit(s), division(s) or subsidiary of the listed entity or any other restructuring.
2. Issuance or forfeiture of securities, split or consolidation of shares, buyback of securities, any restriction on transferability of securities or alteration in terms or structure of existing securities including forfeiture, reissue of forfeited securities, alteration of calls, redemption of securities etc.
3. Revision in Rating(s).
4. Outcome of Meetings of the board of directors: The listed entity shall disclose to the Exchange(s), within 30 minutes of the closure of the meeting, held to consider the following:
  - a) Dividends and/or cash bonuses recommended or declared or the decision to pass any dividend and the date on which dividend shall be paid/dispatched;
  - b) any cancellation of dividend with reasons thereof;
  - c) the decision on buyback of securities;
  - d) the decision with respect to fund raising proposed to be undertaken;

- e) Increase in capital by issue of bonus shares through capitalization including the date on which such bonus shares shall be credited/dispatched;
  - f) reissue of forfeited shares or securities, or the issue of shares or securities held in reserve for future issue or the creation in any form or manner of new shares or securities or any other rights, privileges or benefits to subscribe to;
  - g) short particulars of any other alterations of capital, including calls;
  - h) financial results;
  - i) decision on voluntary delisting by the listed entity from stock exchange(s).
5. Agreement (viz. Shareholder agreement(s), Joint Venture Agreement (s), family settlement agreement (s) (to the extent that it impacts management and control of the listed entity), agreement(s) / treaty (ies) / contract (s) with media companies) which are binding and not in normal course of business, revision (s) or amendment (s) and termination (s) thereof.
6. Fraud / defaults by promoter or Key Managerial Personnel or by listed entity or arrest of Key Managerial Personnel or Promoter.
7. Change in directors, Key Managerial Personnel (Managing Director, Chief Executive Officer, Chief Financial Officer, Company Secretary etc.,) Auditor and Compliance Officer.
8. In case of resignation of the auditor of the listed entity, detailed reasons for resignation of auditor, as given by the said auditor, shall be disclosed by the listed entities to the stock exchanges as soon as



possible but not later than twenty four hours of receipt of such reasons from the auditor.

9. Resignation of auditor including reasons for resignation: In case of resignation of an independent director of the listed entity, within seven days from the date of resignation, the following disclosures shall be made to the stock exchanges by the listed entities:
  - a) Detailed reasons for the resignation of independent directors as given by the said director shall be disclosed by the listed entities to the stock exchanges.
  - b) The independent director shall, along with the detailed reasons, also provide a confirmation that there is no other material reasons other than those provided.
  - c) The confirmation as provided by the independent director above shall also be disclosed by the listed entities to the stock exchanges along with the detailed reasons as specified in sub-clause (i) above.
10. Appointment or discontinuation of share transfer agent.
11. Corporate Debt Restructuring.
12. One Time settlement with a bank.
13. Reference to BIFR and winding-up petition filed by any party / creditors.
14. Issuance of notices, call letters, resolutions and circulars sent to shareholders, debenture holders or creditors or any class of them or advertised in the media by the listed entity.

15. Proceedings of Annual and extraordinary general meetings of the listed entity.
16. Amendments to memorandum and articles of association of listed entity, in brief.
17. Schedule of Analyst or institutional investor meet and presentations on financial results made by the listed entity to analysts or institutional investors.
18. The following events in relation to the corporate insolvency resolution process (CIRP) of a listed corporate debtor under the Insolvency Code:
  - a) Filing of application by the corporate applicant for initiation of CIRP, also specifying the amount of default;
  - b) Filing of application by financial creditors for initiation of CIRP against the corporate debtor, also specifying the amount of default;
  - c) Admission of application by the Tribunal, along with amount of default or rejection or withdrawal, as applicable;
  - d) Public announcement made pursuant to order passed by the Tribunal under section 13 of Insolvency Code
  - e) List of creditors as required to be displayed by the corporate debtor under regulation 13(2)(c) of the IBBI (Insolvency Resolution Process for Corporate Persons) Regulations, 2016;
  - f) Appointment/ Replacement of the Resolution Professional;
  - g) Prior or post-facto intimation of the meetings of Committee of Creditors;
  - h) Brief particulars of invitation of resolution plans under section 25(2)(h) of Insolvency Code in the Form specified under regulation 36A(5) of the IBBI (Insolvency Resolution Process for Corporate Persons) Regulations, 2016;

- i) Number of resolution plans received by Resolution Professional;
- j) Filing of resolution plan with the Tribunal;
- k) Approval of resolution plan by the Tribunal or rejection, if applicable;
- l) Salient features, not involving commercial secrets, of the resolution plan approved by the Tribunal, in such form as may be specified;
- m) Any other material information not involving commercial secrets.

## ANNEXURES - 2

### **EVENTS WHICH SHALL BE DISCLOSED UPON APPLICATION OF THE GUIDELINES FOR MATERIALITY REFERRED SUB-REGULATION (4) OF REGULATION (30)**

1. Commencement or any postponement in the date of commencement of commercial production or commercial operations of any unit/ division.
2. Change in the general character or nature of business brought about by arrangements for strategic, technical, manufacturing, or marketing tie-up, adoption of new line of business or closure of operations of any unit/ division (entirely or piecemeal).
3. Capacity addition or product launch.
4. Awarding, bagging / receiving, amendment or termination of awarded / bagged orders/ contracts not in the normal course of business.
5. Agreements viz. Loan agreement (s) (as a borrower) or any other agreement (s) which are binding and not in the normal course of the business and revision (s) or amendment (s) or termination (s) thereof.
6. Disruption of operations of any one or more units or division of the listed entity due to natural calamity (earthquake, flood, fire etc), force majeure or events such as strikes, lockouts etc.,
7. Effect (s) arising out of change in the regulatory framework

applicable to the listed entity.

8. Litigation (s)/ dispute (s) / regulatory action (s) with impact.
9. Fraud/defaults etc. by directors (other than key managerial personnel) or employees of listed entity.
10. Options to purchase securities including any ESOP /ESPSScheme.
11. Giving of guarantees or indemnity or becoming a surety for any third party.
12. Granting, withdrawal, surrender, cancellation or suspension of key licenses or regulatory approvals.

**ANNEXURES - 3**

- (i) Any other information/ event viz. major development that is likely to affect business, e.g. emergence of new technologies, expiry of patents, any change of accounting policy that may have significant impact on the accounts, etc and brief details thereof and any other information which is exclusively know to the listed entity which may be necessary to enable holders of securities of listed entity to appraise its position and to avoid the establishment of a false market in such securities.
  
- (ii) Without prejudice to the generality of Annexure 1 and 2 and point no. (i) above, the listed entity may make disclosures of event / information as specified by the Board from time to time.
